Such demonstrations have been quite successful in New York. Every month in New York, tax refusers pay their phone bills in person as a group and then give the money to squatters or other community groups. The other major item of business is the Alternate Fund, which we hope to get fully launched soon. You're welcome to bring other items of business.

WRITE YOUR FRIENDLY LOCAL BANK! If your bank has been imposing a service charge each time IRS takes money from your account, write it a nice letter explaining your reasons of conscience for your tax refusal and asking it not to impose service charges for IRS collection. Such letters have secured policy reversals at banks in other cities. Let us know if you are successful. Also let us know of any banks that don't charge now.
