THESE ARE THE MEN WHO CAUSED NORTH WARD DISORDERS...

The tragic events of the last few weeks in the North Ward, are directly attributable to the well publicized poison of the Anthony Imperiale of the ward who have incited young people into racist mob action, that has caused the death of one youth. Imperiale's loud mocking refusal to abide by the decision in the Kawaida Towers matter he has made the catalyst for recent white mob disorder in the North Ward. As well as his continuous assault on all Blacks in NewArk.

What is equally tragic is that public officials who already have information necessary to bring Mr. Imperiale's reign of terror to a halt do not do so. It is known that Mr. Imperiale perjured himself before Judge Kimmelman in denying he met with Imamu Baraka weeks before the groundbreaking of Kawaida Towers. So many people believe in Mr. Imperiale, but he should be exposed as the unprincipled liar he is. When will the authorities move to compel Imperiale to appear before court again?

for. "Moose" Modica is also well known as the "field marshal" for the mob actions in the North Ward of the last few weeks, steering the crowds of maddened youth through defenseless Black neighborhoods, wearing

his legal gun. We wonder if Sheriff Cryan authorized this activity. And further if the democratic voters who support Mr. Cryan are all aware of his role in supporting treachery and violence against Black taxpayers in the North Ward??

Racist mob tactics against Black people are not new in America, un-

They will merely incite the people to struggle harder to secure their families and their communities.

The decision in favor of the construction of Kawaida Towers is ironic, in the sense that actually it says what we at the Temple of Kawaida maintained from the start, that the Kawaida Towers development is not only legal, but a much needed addition to the NewArk community.

Judge Kimmelman has not only confirmed our belief, but reaffirmed the legal impeccability of the endeavour, and in so doing dismissed the self-serving, illy conceived arguments of those pitiful social perverts whose lives are given to struggling against the progress of the

poor. In the case of the specific enemies of Kawaida Towers, they have raised questions about the legality of the tax abatement, and that has been crushed. They have questioned whether there was blighted areas in NewArk justifying the tax abatement, and this spurious obvious obstruction was dismissed. The very NewArk politician who introduced the Kawaida Towers measure to the City Council, and later to serve his own political perversions, claimed he had no knowledge of what he was doing; he has been publicly and legally repudiated. As have the

rest of the racists and criminals on the City Council who under the duress of a Klansman led mob also claimed they did not understand what they were signing. Even though it was explained to them on three different occasions. Judge Kimmelman has also exposed them in their lie.

These obstructors to the community's will also raised questions about whether Kawaida Towers met advanced planning requirements, since it was an expenditure of public funds. The decision clearly dismisses these allegations in pointing out that there has been no expenditure of public funds, of the NewArk municipality, or of the state. The HFA is a state agency which has made a mortgage loan to a qualified agency. It is an investment program which does not tax the state.

FBI KILLS MUSLIM ... WAS "WRONG MAN"!!

BATON ROUGE, LA. (AAN-S)—Two FBI agents last week shot and killed a Black Muslim in Baton Rouge during an arrest attempt, but later acknowledged that he was the wrong man.

The incident represents the latest in a series of violent clashes over the past few months between Black Muslims and police authorities across the nation.

Last month alone three persons were killed and seven others wounded as a result of confrontations between the followers of Elijah Muhammad and police in Atlanta and Oklahoma City.

In the latest incident, two "white"

conspiracy to stop the work of Black Nationalists & PanAfrikanists in this country. In September of this year the Communist Party is calling a meeting of some 2,000 people in Buffalo, N.Y. to try and devise a way to stop the work of Black nationalists and Pan Afrikanists in the United States and throughout the world. To stop brothers and sisters from working to build a nation for ourselves. The rate of frame-up cases among Black nationalists will increase. So we better get ready for it!

This time it was Brother Sonny "Abubadika" Carson; tomorrow it may be one of us. We all must realize the reason these charges have been created and slapped on Brother Carson—because he is a nationalist, and like H. Rap Brown, Maulana Karenga, Ahmed Evans, and countless other Black Political Prisoners, he is being jailed for trying to represent the will of our people.

BROOKLYN, N.Y. (AANS) — Sonny "Abubadika" Carson, the fiery, outspoken one-time leader of Brooklyn CORE, surrendered to police last week to face multiple charges in connection with the death of one man and the wounding of another.

Brother Carson is charged with murder, kidnapping, burglary and possession of dangerous weapons, all following the alleged abduction of two men who were supposed to have twice robbed a Black owned hotel he manages in the Bedford-Stuyvesant section of the city.

Brother Carson, who has been charged along with seven associates, is "said" to have picked up the men in a car last month. One was shot to death in a struggle inside the vehicle, while a second was thrown out at a deserted place, shot in the head and left for dead, according to police.

Henry Manley, 26, lived however, and later told police the identity of those he claimed to have attacked him and Philip Williams, 34. They included Carson, Ali Lamont, and his brother, Jackie, Wallace Hammond and Calvin Smith, all of Brooklyn.

Three other suspects were still being sought.

Brother Carson is only one of many Black nationalists being framed with numerous jive charges in order to eliminate their voice in the Black community. Basically there has been no evidence found to show that Brother Carson was involved in any of the fake charges which the police have dropped on him.

There is definitely a national

FBI agents identified as Bill Woods and Delbert Hahn went to the home of Milton Leon Scott, 21, and attempted to arrest him for Army desertion.

Scott reportedly told the agents that he had never been in the Army, that he would not go with them and then tried to close the door to his house.

A struggle ensued when the agents entered the house and, according to Scott's wife, Beverly, they dragged Scott out of his home. The 19-year-old widow says she later heard two shots and saw the FBI agents trying to kick her husband after he had been shot. The official FBI story later in the

week, however, was that the young Muslim had assaulted the officers with a blackjack and attempted to get their guns.

The man the FBI was actually looking for was identified as Calvin Henry—currently serving a seven year jail sentence in California.

Henry had reportedly entered the army in 1972 using identification belonging to Scott. Scott's family told a local television station that he had reported his wallet and identification stolen in 1970.

Other violent Black Muslim police clashes have occurred in New York and California.

ANTIQUA ALD DRAWS 14,000 —Despite Neo-Colonialist Ban!

May 26th, 1973 will go down in history as one of the most important and crucial days of the twentieth century in Antigua. This Caribbean Island will not and cannot be the same as a result of what took place that day. Declared Afrikan Liberation Day, it was not just another Liberation Day in Antigua, but more importantly it marked a period when the people with the Afro Caribbean Liberation Movement stood up and made it abundantly clear that no force of arms would daunt or prevent them from fighting for their freedom; that in the final analysis power must rest firmly with the people and not in the hands of a few.

That over 14,000 Afro-Caribbean people united and rallied, in spite of and not because of, the threat of the full force of the law by the ruling régime, is positive proof that our people like others the world over will

do all in their power to attain their freedom and liberation.

The march followed the original route stopping briefly in front of the Governor's residence and the office of the British High Commissioner.

At this point thousands of people showed their support for the liberation struggles by shouting "Freedom to the people of Mozambique, Freedom to the people of Guinea Bissau." At about 1:45 p.m. the rally arrived at the grounds where the addresses were to be given.

No incident whatsoever had taken place and it was generally felt that the police decided against any action knowing fully well that the thousands of people who rallied would have shown their righteous indignation. And despite the neo-colonialist ban, this march, as well as others was really a success. A Luta Continua!!

WILL KERR TAKE CONTROL OF THE IMPERIALE (Police) DEPARTMENT?

Police Director Edward Kerr, the city's first Black police director has been approved by the Newark City Council, after attempts to have him confirmed, since the resignation of John Redden last year. The appointment took so long to approve, because of the racist obstructions by the "SICKS" on the City Council, but Director Kerr finally won his first battle. What remains to be seen is what Director Kerr will do to insure the safety and well being of the majority of the citizens of this city, and how we will receive adequate police protection from criminals and racist police who roam the streets at will. The new police director must be firm in his position against social misfits in and out of uniform.

What Black people and other powerless people in this society want from the police and from such as Police Director Kerr is that they enforce the laws equally. That is what Blacks, particularly, and all poor people in general, have been asking

for a very long time, that the laws of the land be enforced equally. And that is all we are asking of Police Director Kerr, that he enforce the laws equally. It is simply that because he has Black skin we thought he would at least be sensitive to those laws that were not being enforced where Black people's and other oppressed people's rights are concerned.

Finally, we would like to ask, in this same vein,

1) Will the Black and Puerto Rican citizens of the North Ward be protected from rampaging whites including on and off duty white policemen?

2) Will Kerr see that his police actually protect workers at Kawaida Towers when work resumes rather than aid Imperiale, as has been the case?

3) Will Kerr explain why Tactical Policeman Caprio, Badge #905, continues to function as one of Imperiale's "legal guns," and body guards? (We have already raised the question of why Sheriff's Deputy Santos "Moose" Modica continues to function in this same capacity, paid by the County, as another Imperiale "legal gun.")

4) Why hasn't Imperiale been arrested for inciting riot, if Imamu Baraka functioned in the same capacity as Imperiale, stirring up riots every night against whites, he would be arrested. We want equal enforcement of the law.

5) Will he continue to allow Ron Gasperenetti, who is listed in police files as being "unfit psychologi-

cally" for police work, to continue?

6) What will he do to put an end to the Imperiale-Police assault and harassment of Black and Puerto Rican citizens all over the city?

So most of all what we are asking of Director Kerr is that he be a man! And stand up for what he very clearly knows is right! He should stop hiding behind the paper mask of public official, just like our mayor should stop hiding behind that ill fitting disguise and stand up and be counted on the side of the positive forces in the community and the world.

There are observers who say that

two white captains really run the Newark Police Department and that Director Kerr has little to say about it. It is obvious that Imperiale influences certain racist elements in the Police Department . . . how much input can Director Kerr make in reality? That's a good question!

But nevertheless, there is nothing unreal about what the majority of the citizens in Newark demand of Director Kerr—only that they be protected and the laws are enforced equally. All Black people will be watching to see if Kerr is strong enough to handle this critical task!

SPECIAL NEWS! WINDOWS SHOT OUT, AGAIN!

Early Monday morning July 31, shotgun blasts ripped through the downstairs windows of Committee For Unified Newark's main office at 502 High St., and also through the downstairs classrooms at Afrikan Free School. It is obvious that the attackers were white policemen. A short time before those blasts, Santos "Moose" Modica & several of his police associates were seen twice riding through the Central Ward, passing at high speed in front of the Temple of Kawaida, 13 Belmont Ave., Modica was recognized by Cheo Dhati Changa who is testifying before a grand jury that Modica is the bodyguard of Anthony Imperiale.

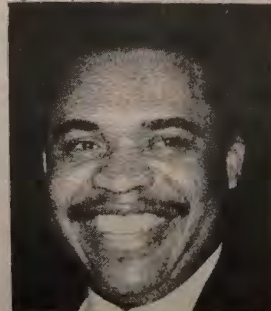
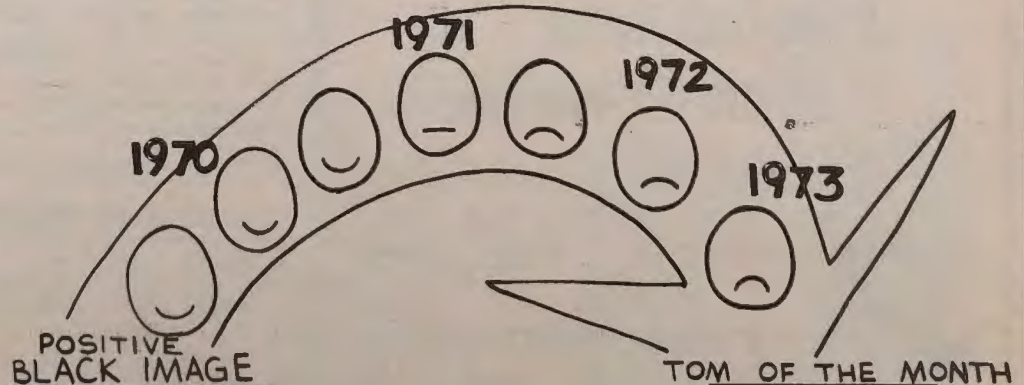

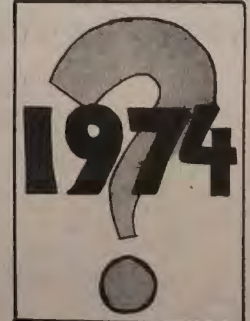

IS THIS TRIP NECESSARY?

Most of the challenges made to Kawaida Towers probably were understood as futile by any lawyer who could have put them together in the first place.

The charge that Kawaida Towers breeds crime, is the surest measure of racism. Are people who live in the high rises just up the street on Mt. Prospect Avenue also in that category of crime breeders, or are they exempted because they are mostly white? Are the penthouses of Park Avenue and Fifth Avenue, breeders of crime because they're high? It is the lack of services that cause slum conditions, the lack of concern by management and government that causes slums and crime. The lack of involvement by the rich in the plight of the poor causes crime.

The Judge has also added that the obstructors had not even filed their challenges on time, and they could have well been dismissed simply because they did not meet the technical requirements of competent legal process. However, in an attempt to give these miscreants all the rope in the world, the judge enterprisingly allowed them to file even after the permissible time for such filing. And still all complaints were dismissed "with prejudice."

But next we must ask the question, what power does Mr. Imperiale hold over the would be executors of law and order that they will not roll over his racist obstructions to the public good but must give it endless hearing,

endless dignity when it deserves none? Mr. Imperiale, it should be added again and again, himself knew about the project beforehand, and Imamu Baraka would challenge him to go into a court of law under oath and say that he did not meet with him several weeks before the ground breaking and discuss how firms he knew could get employment at Kawaida Towers. Perhaps he has perjured himself already before Judge Kimmelman? These facts are known, why don't the suitable agencies act?

In the meantime the Temple of Kawaida is now actively seeking to begin building. We are meeting with the contractor to set up a building schedule. We are notifying the unions of Judge Kimmelman's decision, expecting them to rid themselves of their racist association with legally crushed racists.

We will also go back into court to seek the reduction of numbers of pickets in front of the site, in the presence of the racists melodramatic announcement of "fights to the death," &c.

We are moving forward certainly. We have won another court case, and we will continue to win any others. The development is legal. But all would be supporters of law must see that in law the development rises, otherwise the entire community is being subjugated to the unlawful disorder of a vest pocket fascist.

But KAWAIDA TOWERS WILL CERTAINLY RISE!

Because all of Afrika is in a continuing struggle against Colonialism and its insidious offspring, NeoColonialism, the accepting of aid from the wealthy countries is always wrought with dangers. First, these six countries are among the poorest in Afrika, the lack of developed technology, makes the drought situation even worse, because it cannot be fought within the countries in ways possible for highly industrialized countries.

According to a congressional report the United States has given about 18 million dollars in surplus foodstuffs to the area, during this five year period, although last year 15 million dollars went into Bangladesh, alone! It is obvious that governmental agencies in the United States & the U.S. Gov't itself could stem the ravages of the drought through interest free loans and technical assistance, without neocolonial political strings. A massive "marshall plan" could be initiated to transform these regions through use of the modern technology of the industrialized nations, at the same time allowing these countries to transfer this technology to their own nationals, so that these efforts will not turn into yet another exercise in imperialist domination and cultural elitism.

Toward this end we would like to quote directly some methods of influencing American policy toward the Afrikan drought and Afrikan policy in general.

VICIOUS ATTACK ON BLACK COMMUNITY

On Wednesday Julai 11th, following a racist rally by Anthony Imperiale the Black community was set upon by three to four-hundred white men, armed with baseball bats, iron pipes, guns, & sticks. As a result of this vicious attack upon the Black community brothers & sisters in the north ward have set forth to become unified & self-determining by forming the North Ward Black Unified Committee.

Following the disturbances, several incidents have occurred in the Black community of the North Ward. White people have sought to terrorize the Black residents of the North Ward. Immediately after this vicious attack on the Black community by hundreds of demented white youths, white policemen also aided Imperiale and his goons by stopping and harassing every Black person they saw. One Black woman, Mrs. Lucy Bullock, was harassed and arrested by the police.

The writer of this article is a strong and hard pushing sister. And because of her out-spoken qualities as a righteous Black woman in exposing the racism in the North Ward, her home was firebombed several days following the disturbances. The incident occurred around 3:00 o'clock in the morning, while she, two small children and her 96-year-old aunt were in the building. Fortunately all four of them escaped. But this was only after the firemen had ripped a hole in the wall of her room to get them out.

Presently the north ward is very tense. The Mayor and the police chief have played a very low role (hardly any role at all!) in protecting the rights of Black people.

These men have all the power in their positions in NewArk to take actions against Imperiale, a maniac who is the perpetrator of all the evil blows plaguing the Black community to task.

If Mayor Gibson, who owes his allegiance to the Black & Puerto Rican community and who came out of the "Black & Puerto Rican Convention, cannot stand up to Ant-Knee Imperiale, then something is wrong, and the mayor should call for a Grand Jury investigation to bring out all enemies of the Black community, before his credibility is questioned further.

The Black and Puerto Rican Community must be made safe. Every man, woman, & child must live in security; or those men responsible for the lack of security must be removed from their positions.

Kerr have a direct responsibility to secure and protect all the people of NewArk. We understand their job is complicated by the fact that the NewArk Police Department is still dominated by anti-Black white cops, many of whom identify directly with the violent racism of Imperiale & c. But Mayor Gibson and Police Director Kerr must take clear, forceful and direct action to secure the Black community in the North Ward, and put an end to the rule by mob violence that is sanctioned by many white politicians and white policemen in the North Ward today. It is obvious that part of the mob's work, and Imperiale and company's intention is to embarrass and de-testicle these two Black officials. But Gibson and Kerr must support and protect the community that supported and protects them.

Long Kitchens of Weequahic Avenue: "My opinion is that Kerr and Gibson have only titles with no power behind them. There's not too much they can do in NewArk because they don't control it."



Lucille Peterson of Ludlow Street: "If Gibson and Kerr are really interested in helping the community and preventing a riot, they would bring in the National Guards until Kawaida Towers gets built and arrest Imperiale if he breaks the law."



Irene Shorter of Mrytle Avenue (Jersey Clty): "I think Black people are getting a lot abuse in NewArk. I just can't see why Kawaida Towers is prolonged and why Kerr and Gibson will not take a stand in enforcing the law."



Tawakali (Gloria Pitchford) of Burchard Avenue (East Orange): "First of all, assign Black policemen to the area and secondly, Gibson should meet with the North Ward Black Committee to sincerely try to resolve their problems."

"Finally I am positive that the puppets presently picked by the white boss will be rejected, because we are determined to bring 'Unity in the Community'."

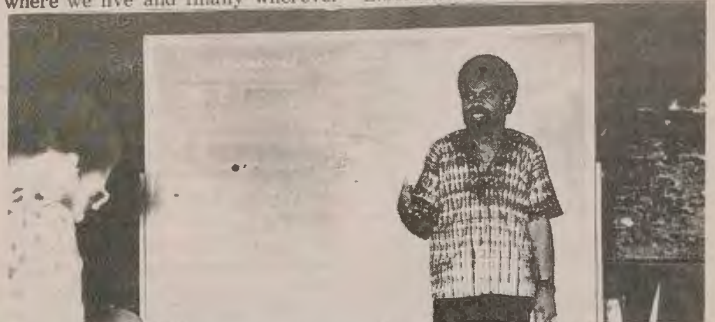
On July 7, 1973, the Committee For Unified NewArk and other cadre organizations of the Kawaida faith came together in a day of work and study, to celebrate Saba Saba, the seventh day of the seventh month. 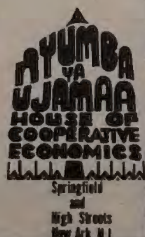

1. Urge your Representative and Senators to find out what the State Department is doing about the drought emergency in Afrika.
2. Let the Assistant Secretary of State for Afrikan Affairs, Mr. David Newsom (State Department, Washington, D.C. 20520), know of your concern.
3. Write the Chairman of the Foreign Relations Committee, Senator J.W. Fulbright, and the Chairman of the House Foreign Affairs Committee, Representative Thomas E. Morgan, and to members of these committees to urge them:
 - To amend the Foreign Aid Bill to include special provision for relief and reconstruction of the Afrikan drought area.
 - To support the amendment to the Foreign Assistance Bill in the House, co-sponsored by 22 members of the Foreign Affairs Committee (including Chairman Diggs), which would focus future U.S. development finance on programs which would help the poorest sections of the population, in the poorest countries, especially in sectors such as food production, rural development and nutrition, and appropriate education.
4. Publicize the drought emergency, and the urgency of making U.S. development finance available to the least developed countries, in each church, community group or organization to which you belong.

AFRIKAN HERO



Major-General Mohamed Siad Barre

Somalia is one of the most progressive countries in Afrika and is led by one of the most progressive and revolutionary leaders in Afrika.

Major-General Mohamed Siad Barre is the president of the Supreme Revolutionary Council of Somali Democratic Republic. He is the leader of a country which has been the playground of international imperialism for nearly a century during the partitioning of Afrika, commonly known as the 'European Scramble for Afrika'. He is the leader of a country which was divided by oppression in five parts—British, Italian, French, Ethiopian, & an area included in the former British colony of Kenya—under a nation of people who were determined to liberate their country and unite their people under an independent Government.

In 1960 the Samaliland Protectorate held by Britain and Somalia, a colony held by Italy, achieved their independence and immediately united to form the Somali Republic.

The leader of the country at that time was Dr. Shermarke; but on October 15, 1969, he was assassinated by his own bodyguard while touring the northern part of the country. This brought political confusion to a climax.

Moved by a desire to restore the pride and traditional greatness of his people and the greatness of Somalia, Major-General Barre feels that his nation is definitely on the road to recovery and this is evident in Somalia's participation in the decisions of the United Nations.

Major-General Barre has influenced and inspired the people of Somalia to be determined to succeed; and currently they are changing Somalia into an Afrikan socialist nation in seeking to achieve National Liberation.

AFRIKAN REVOLUTIONARY CLASS-VALUE ANALYSIS Pt. 1

The present period is a time of rapid, dazzling, flux. Events, issues, personalities, conditions, whiz by with blinding velocity. Change threatens all permanencies, change, transformation, revolution, the results of evolution. And we here, in the United States are actually in the spine of a dissolving entity. They still waiting for the revolution. But it will be Afrikans, Asians, & Latin Americans who will force world transformation!

The white left don't even dig Mao, whom they now call "A Nationalist", because Mao has pointed out that under the Race-Class control of European racism, the entire "third world" (Afro-Asian-Latin American) constitutes a world working class to the white boy's world bourgeoisie. This is what shakes up the theories of international integration i.e., European Hegemony (control) palmed off as Marxism, because whites are a world class of owners . . . trying to control the means of

production of the entire world.

Here in the U.S. it is even more pitiful. Can you imagine calling Ant-Knee Imperialism, part of "the revolutionary proletariat". White workers in America are a fake bourgeoisie because they take part in the exploitation of Blacks & other oppressed people in NewArk or Hanoi. Subsequently all Blacks are part of the working class, because our race is an underclass (in relationship to whites). Even tho, economically, there is disparity between the "richest" black and the poorest, both are simple niggers to the poorest cracker alive. (Tho this does not mean that there are no class distinctions between blacks & blacks. The New Board of Education: What to Expect
