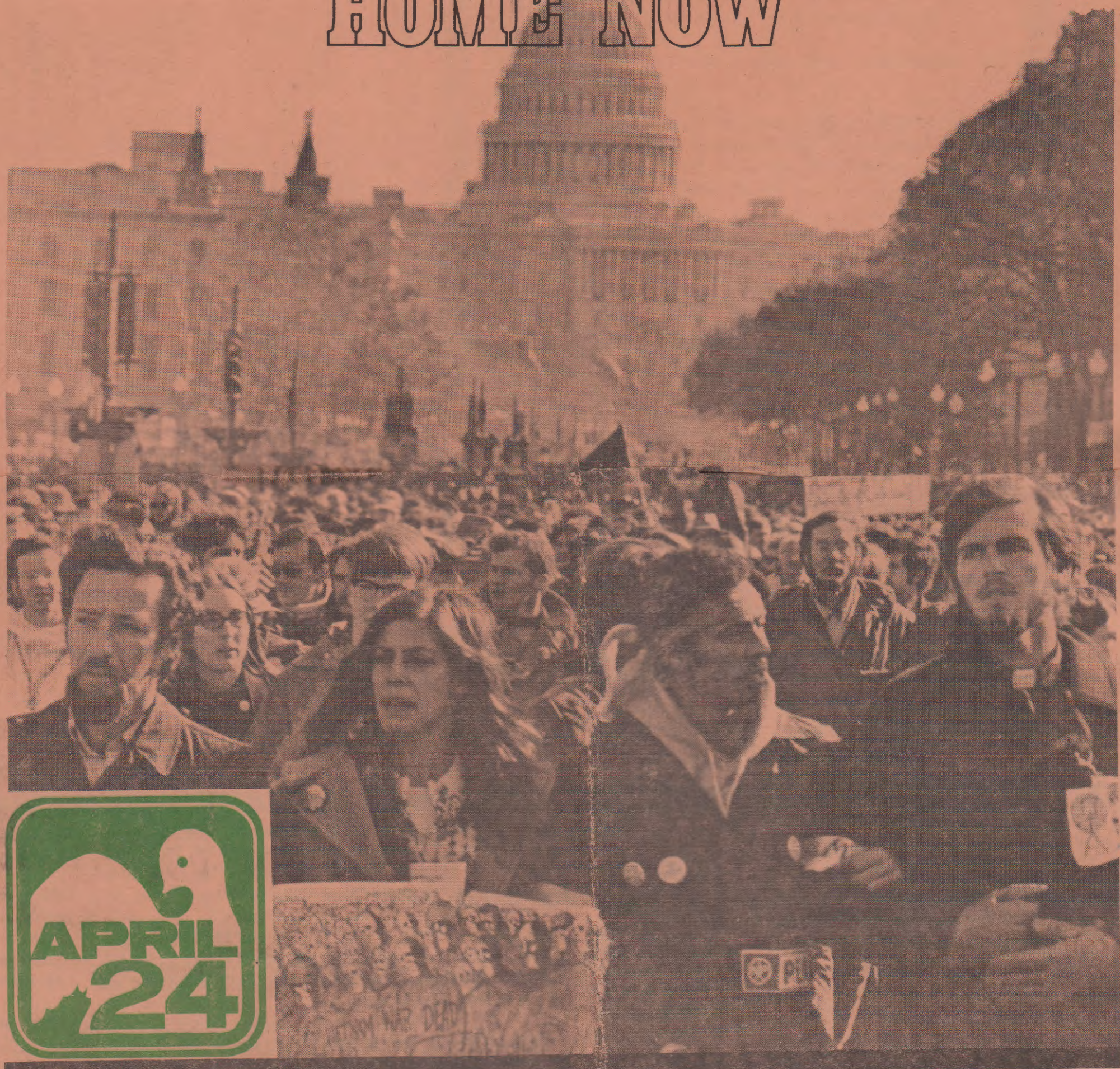

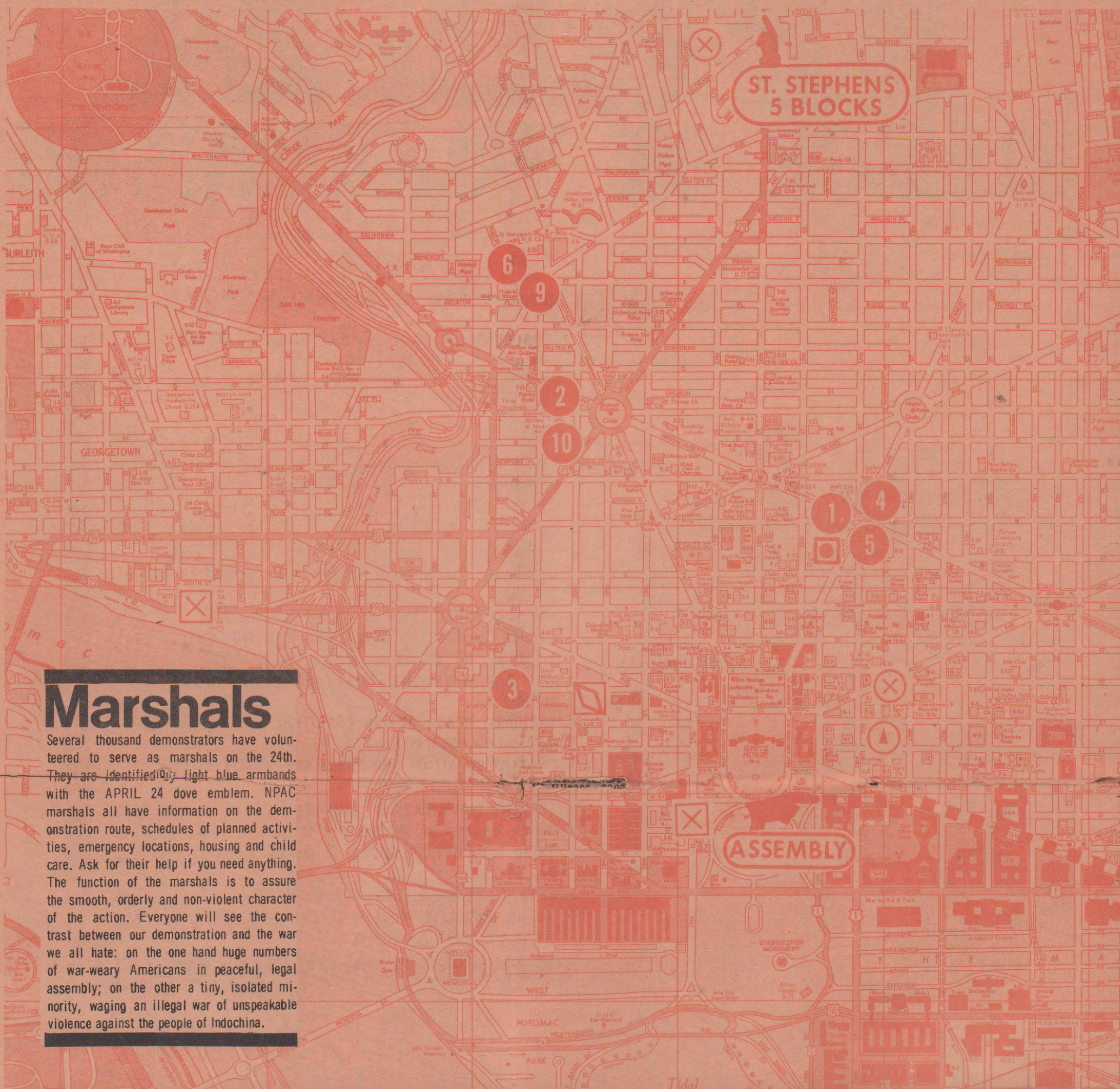

Marshals

Several thousand demonstrators have volunteered to serve as marshals on the 24th. They are identified by light blue armbands with the APRIL 24 dove emblem. NPAC marshals all have information on the demonstration route, schedules of planned activities, emergency locations, housing and child care. Ask for their help if you need anything. The function of the marshals is to assure the smooth, orderly and non-violent character of the action. Everyone will see the contrast between our demonstration and the war we all hate: on the one hand huge numbers of war-weary Americans in peaceful, legal assembly; on the other a tiny, isolated minority, waging an illegal war of unspeakable violence against the people of Indochina.

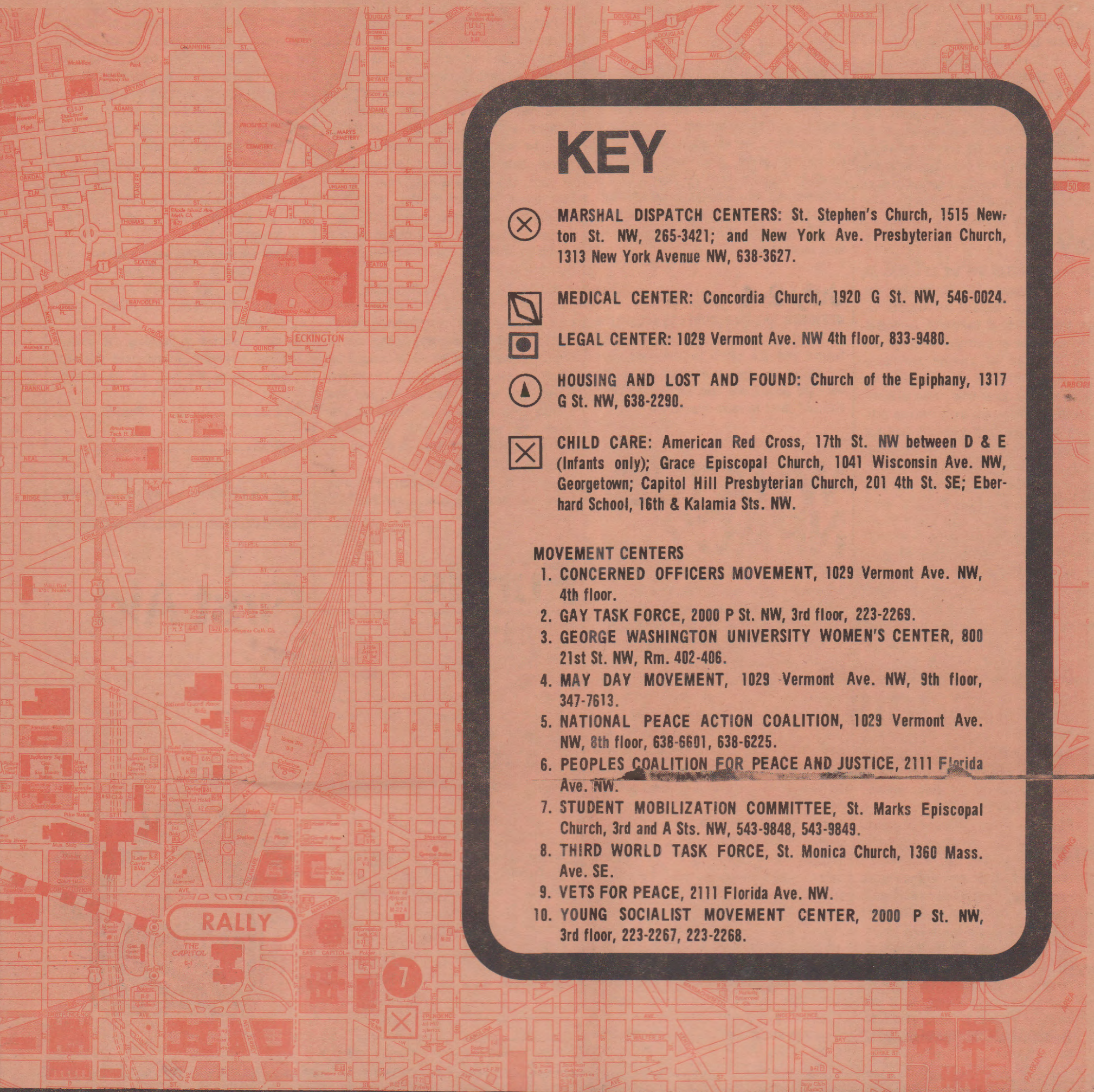

WHAT NEXT?

April 24th must be the starting point for a new and continuing mobilization of the American people to demand that the government end ALL U.S. military involvement in Southeast Asia IMMEDIATELY. April 24th has surfaced the broadest coalition for immediate and total withdrawal that this country has ever seen. The momentum and breadth of this action will build the rest of the spring antiwar calendar in every community in this country. From here we must go back to our communities to build BUILD BUILD BUILD

May 5

NATIONAL MORATORIUM ON BUSINESS AS USUAL. To commemorate the murders one year ago at Kent, Jackson and Augusta following the invasion of Cambodia. Campuses will be the scene of memorial meetings and utilized as bases for massive community antiwar work. Shops and offices will be the scene of extended lunch-time memorial meetings. Late afternoon and early evening antiwar marches, rallies and memorial meetings will be held in hundreds of cities and towns. Federal employees in Washington will be voting on an antiwar referendum leading up to a massive federal employees' rally May 5 at which the referendum results will be announced. The call for a campus and high school Moratorium has been issued by the Student Mobilization Committee, the National Student Association, and the Association of Student Governments, the nation's three largest student organizations. GI SOLIDARITY DAY. To mark Armed Forces Day in a manner fitting the times. GIs at bases around the country will be holding antiwar actions and civilian peace groups should be at the bases to provide all the support possible. In addition, civilian antiwar groups should express their solidarity by leafletting bases, bus stations, airports, etc. Possibilities for GI Teach-Ins, picnics, press conferences, etc. should be explored. NATIONAL ANTIWAR CONFERENCE. Called by NPAC. To evaluate the spring peace offensive and lay plans for continued mass antiwar action. Open to everyone against the war--one person, one vote. Contact the NPAC National Office for more information.

WHAT IS NPAC?

The National Peace Action Coalition, the sponsor of today's demonstration, is the broadest and most representative antiwar formation ever established in the United States. It has hundreds of affiliated groups from all over the country: labor unions, women's organizations, students (including the Student Mobilization Committee), local community peace groups, religious bodies, Third World groups, professionals, GIs and veterans, gay liberation groups, faculty committees, and a vast number of others. While strictly non-

partisan, NPAC includes many political groups representing conservative, moderate, liberal and radical constituencies. NPAC stands for the immediate, total and unconditional withdrawal of all U.S. military forces, warplanes and materiel from Southeast Asia. NPAC believes that masses of people must be involved to end the war. NPAC's tactics are peaceful, legal, non-violent and non-confrontational.

JOIN NPAC! All groups are welcome. NPAC is completely democratic and its Steering Committee is open to all affiliates. Now is the time to join with others in ending the bloodshed and bringing ALL the troops home NOW!

Getting it together

One of the most important aspects of the buildup for April 24th has been the springing up of dozens of local Peace Action Coalitions in every corner of the country. A Peace Action Coalition is an organization which brings together representatives of every section of the community which is against the war--students, workers, women, Blacks, Puerto Ricans, gays, GIs, unemployed, Chicanos, religious groups, peace committees, veterans--everyone. Local PACs are the vehicle for coordinating the activities of the various local peace groups, keeping them in touch, sharing ideas. The local PAC is what brings everyone together for national demonstrations and other antiwar activities--and what gives them an organized voice in helping to determine what those national actions will be.

If a PAC has not as yet been organized in your area, set one up. With antiwar sentiment so widespread, there's really nothing to it. The NPAC National Office has an organizing manual and all the necessary materials are available on request--we can even provide you with a speaker for your first meeting. 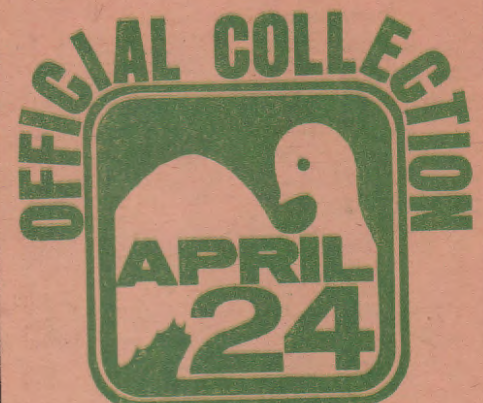

First Aid

Medics at past actions have treated large numbers of demonstrators for cut and blistered feet and for severe sunburn. To prevent these casualties:

1. Wear shoes. It is hard to avoid broken bottles, stones, etc. in a large crowd.
2. Cover your head and arms in strong sunlight. This is particularly important for small children.
