On Jan. 14, 15 and climatically on Jan. 23, members of D.C. Women's Liberation interrupted and disrupted Senator Gaylord Nelson's Senate subcommittee hearings on the PILL (the specific issue: informed consent). Intensely pertinent questions have been raised, the media has carried the news across the nation, sisters everywhere applaud and encourage our actions, and even the powers-that-be have not remained unperturbed. A meeting with Senator Nelson to be followed by a W.L. press conference is scheduled for Jan. 29. The next actions envisioned are a women's survey on the pill (What did your doctor tell you would happen? What did happen?) and counter-hearings by women and for women, possibly the last weekend in February.
