FLASH: HOUSE IMMINENT

The first is a 14 room house at 1929 19th Street NW (behind the Hilton). The rent is \$750 a month with a two year lease. It's a bit steep but feasible if we have enough monthly sustainers (yes, that is another gentle hint for money) and considering the fact that we are counting on \$350 a month from groups that are now paying that much for office space elsewhere. The owners/occupants are painting the house now and are interested in renting it as soon as possible. Two members of the Housing Committee have seen it and loved it, so we'd love to have everyone see it themselves. The house will be open for everyone to see on Monday, June 12 from 5-7:30 p.m. The family who live there will be in the middle of dinner, but say they don't mind. If we decide on this building, it'll be necessary for the zoning to be changed and that may take some time, so the sooner we make a decision the better.

The second possibility is a mind-blower! It's a bit unusual but bear with us. It's a 22 room (!) house near Rhode Island Ave. & 15th Street. It's now rented by 3 people, two women and a man, who have been looking for other people to share the house with. We've spoken with one of the women, and she is very receptive to having the Center there. However, they want to continue living there. The clincher is the rent--would you believe \$250? YES! Members of the Housing Committee are going to see the house on Friday, June 9, and if things look good, we'll try to set up Mon., June 12 from 5-7:30pm also as the time for everyone to see it. So...go first to the 19th Street house, then to this house. Don't have the exact address at this writing, but we'll leave a message at the 19th Street house.

We know it's been a frustrating five months of looking, and we're very anxious to have everyone see some tangible results. So please come see the houses - Mon., June 12 from 5-7:30pm - then come to the NEXT GENERAL MEETING on Thurs. June 15 to make THE decision.

Prospects look hopeful for getting several performers; we're trying for Joni Mitchell, Judy Collins, Joan Baez, Roberta Flack, Carol King and our great local talent. (We think some of them are interested in being in the skits or reading poetry as well as singing!)

We're shooting for Cole Field House at U. of Md. - capacity 12,000 people, and maybe for free. If we charge \$5 a ticket, we can net quite a lot of money, even taking into account the cost of publicity. We'd like it to be held in late Sept. or early Oct. Work has to begin now. WOMEN SUSTAINING WOMEN \$0\$0\$0\$0\$0\$0\$

Come on women! At this point only a few women are supporting all of us with their sustainers - 19 to be exact, for a total of \$258. We know your intentions are good, so get those sustainer forms out of your desk drawers and get them in so we can really say women are sustaining women. Some people haven't sent their forms in because they're worried about having their money earmarked for specific projects - that's no problem. We'll be sure to earmark it in our records. Also, don't worry about pledging a lot of money. If everyone on the mailing list pledged \$2 to \$5 a month we'd reach our goal: \$1,000 a month for rent and utilities on one of the 2 houses we've located. Pledge whatever you can afford on a monthly basis. Be sure to specify the total amount of your sustainer as well as the monthly amounts. For example, \$60 - \$5 a month for 12 months, payments to begin in June.

It's difficult asking anyone - even sisters - for money. Help us out and remind your friends at meetings and things. If you need a form, call Vance at 223-3252. We'll have sustainer forms at general meetings also.

MORE ON \$\$\$\$ (and sexism)

So far four flat refusals from the six foundations the Funding Committee wrote to: Stern Family Foundation, Rockefeller Brothers Fund, Hattie M. Strong, and Cafritz. The two still not heard from are the Public Welfare Fndtn. and the Eugene & Agnes E. Meyer Fndtn. The experience has been a consciousness raising one for all of us. The Strong Fndtn. said they are only interested in funding "disadvantaged groups!" How's that for sexism! Several things are clear: the oppression of women is still not taken seriously by the institutions of this society. Second, the problems of women are still their own problems in the eyes of the men who control the wealth. Third, we have barely begun to make the force and power of women known.

Rave reviews for the Women's Song & Dance Fest of May 12 have been pouring in at such a rate that we've been moved by popular demand (and by the funds it brought in) to start planning another dance for the summer.

LEGAL PROJECT

After a meeting with the board of directors of the Women's Legal Defense Fund on Tuesday, May 30 the legal project has decided to become the legal counseling committee of WLDF. This means that the legal office in the Center will be the WLDF office which will coordinate test case litigation (receiving calls, screening cases to be taken free by WLDF attorneys, keeping tabs on cases in progress), legal counseling and referral and liberation courses on legal skills.

We would like to expand to actually provide legal services (representation in court) for women, but probably won't be able to do so until we get funding, for which WLDF is in the process of applying. A legal counseling committee meeting was held Tuesday, June 6 and we decided to start work on three counseling programs.

Sharyn Campbell is organizing counseling on sex discrimination in mortgages, credit cards, loans- call her if you want to work on the project or to tell her your own experiences with local banks, credit institutions, home & car buying, etc. or to get counseling before the Women's Center opens at (w) 755-1374, (h) 785-5128.

Elinor Bachrach is talking about organizing employment discrimination counseling or a speaking program on that subject. Call her if you would like to be trained as a counselor or speaker at (w) 225-6306, (h) 338-0083.

Candy Cohen is working with Pat Williams, Ann Freedman, Jackie Williams and Judy Potter to design a training course in domestic relations counseling. They hope also to develop a list of good inexpensive lawyers to whom we can refer women, and to learn when to help women help themselves. If you're interested in being a counselor, call Candy at (w) 387-2500, (h) 232-1396.

There will be a meeting on Tuesday, June 13 at 7:30 p.m. in the Advocate Office, on the 3rd floor of 714-21st St. N.W. to talk about how this legal counseling committee should be formally integrated into the WLDF structure. WLDF also plans to have a general membership meeting to publicize the legal counseling project, recruit more of its members to work on it, and to raise enthusiasm and money for the Women's Center. The legal counseling committee hopes WLDF will be able to pay at least \$25.00 a month rent to the Center and raise that figure once we can collect contributions from clients.

The Rape Counselling Center will open on June 1. The
phone will be in operation 24-hours daily; the number is
333-RAPE. Women who have been raped or attacked will be re-
ferred to discussion groups, where they can talk out their
experience.

We also hope to provide escorts for women who have been
raped. If a woman calls us after she has been raped, and needs
transportation to the hospital or the Center we would like to
be able to help. We have very few cars among women in the
collective, and we feel that asking a woman to take a cab can
only increase her alienation and aloneness. If you have a car
and would be willing to help provide transportation occasionally
could you please call Karen Kollias at 965-3573 or Liz O'Sulli-
van at 234-5354. (We hope that we will be able to reimburse
women for gas, but we can't promise this at the present time).

Also, if you know of anyone who has beds or mattresses they
want to give away, please let us know. We want to provide tem-
porary housing for women at the Center who would otherwise have
to stay alone during the crisis period. We also need mattresses,
mats, and bar-bells for self-defense.

We also have women available who will speak or give rape
conferences for a fee. If you know any groups that would be
interested, please pass that information along.
