#### REPORT FROM THE GENERAL ASSEMBLY AND COORDINATING COUNCIL

The General Assembly met on Thursday, July 6, and ratified the structure for the Women's Center as given in last month's newsletter. The only significant modification was that only three at-large members will be serving for the summer, and in the fall five new at-large members will be chosen. We did manage to meet the quorum of 20 people, however, despite the Washington summer doldrums.

The Coordinating Council met on Monday, July 17, and decided that their quorum for the summer would be seven, since there are a total of 12 group representatives and 3 at-large members. Even though there were about 10 women there, there were still a number of project groups that were not represented, and we urge you to send a replacement if you cannot make it yourself. It's important that everyone be represented at these meetings so that we can keep in contact with each other and feel better about making decisions.

#### MORE HOUSING NEWS

Negotiations were started and broke down quickly on the house at 1929 19th Street, NW — basically a problem of incompatibility with the landlord. However, another prospect is in sight, this one at 1744 Lanier Street, NW, only a couple of blocks from the 18th and Columbia intersection. It's being purchased by a man who will in turn rent it to us for \$400, and it has 10-12 rooms. We haven't been able to look at it yet, and the process of buying it may take a couple of weeks, but if you're interested in more information about it, call Liz Milbrandt at 654-1760.
