EXTRA!!! EXTRA!!!

The next General Assembly meeting will be held on August 10th at 7:30pm (on time) 2nd floor of the Community Bookstore--2028 "P" St., N.W. We have many important matters to discuss and decide. The last G.A. and Coordinating Council meetings unanimously approved the acceptance of the 18 room house located at 1736 "R" St., N.W. (formerly Quicksilver Collective).

We must discuss:

- 1.) Provisions for women living in the Center and their relation to the Women's Center
- 2.) A schedule for moving in and cleaning up duties
- 3.) Discussion of space needs for different projects
- 4.) Paid staff; how many; how much; their roles (last G.A. meeting made a committment for paid staff)
- 5.) How do we enforce our decision-making policies once we move in (re: the Women's Center not endorsing any actions as a group)

....and so on...everyone's ideas are needed!

Proposal: a very lengthy proposal was drawn up discussing the functions of our Women's Center and its specific projects. It is being revised now by Gaitha Hes-selden and will be turned into the Meyer Foundation this week. We are requesting \$20,000. for one-year operating costs for the Center. Keep your feminist fingers CROSSED!

CONCERT COMMITTEE (i.e., more \$\$\$\$\$\$)

There will be a meeting held on Friday August 11th from 7 to 8:30 pm at Kathie Garner's (3155 Adams Mill Road, N.W. #232-1461). It is important for the Women's Center Benefit to grow in participation. The Concert is scheduled for Oct. 6th and much, much preparation is needed. We are asking women to work on skit writing, dancing, poetry, music, and publicity. All help, talent, and energy will be loved in sisterhood. Please come. This will be our biggest fund-raiser yet if we pull together!!!!

1. Bev Fisher will represent the Women's Center on the newly formed advisory council of WETA-Metro Media which plans a series of women's shows.

C.C. Report continued:

3. Women are requested to write or call WETA-TV in support of Feminist Forum which is in danger of being taken over by the male dominated station. For further information call Sharon Campbell at 755-1374.

4. Re: The House--The council enthusiastically approved the rental of the house at 1736 "R" St., N.W. Gayle Peabody investigated zoning and found the house zoned RC5 which means we will have no problem qualifying as a "social club." We will not be able to sell anything but have a kitchen, can make coffee and take donations for it, etc.

5. C.C. (and G.A.) affirmed Washington Women's Art Professionals as members of the Center. They will have a representative on the council.

6. In a budget report Bev Fisher stated that the request to the Meyer Foundation is being submitted this week and is being increased to include 2 paid staff positions.

7. The next Coordinating Council meeting will be held on August 17 at 7:30pm in the Women's Center (1736 "R" St., N.W.). Please be on time. The meeting will deal with allocation of space (rooms) in the Center.
