



## LETTERS TO W.A.R.

Dear W.A.R.

Today we're number four.

Today more and more people are constantly resisting the draft. Draft resistance has become the fourth largest federal crime in the country and is up 100% in the last year. At this moment here are hundreds in jail, thousands in Canada, 2400 draft cases in the courts, and thousands of desertions from the armed forces. Draft resistance implies the refusal of induction, the turn-in of a draft card, willingly rejecting deferments, and although it is not a Selective Service crime; the destruction of draft files.

On Tuesday, we had what I think was an excellent confrontation at the City Council on the ABM--a confrontation that made it clear how the particular issues of peace and priorities that are wrapped up in ABM are connected with the basic issues of living in an undemocratic society. After weeks of trying to get the City Council offices to present a "hearing" on their own, Hahn heard our demands. That was impressive in itself, and got excellent coverage. The city is now more awake on ABM.

But it can't stop there... Since the ABM is not only a "peace" issue but also physically endangers all our efforts for progress, as well as orientating our money to transform the city, and it is a perfect political model of what happens to the powerless people of Washington, a very wide black-white, liberal-radical, young-old coalition ought to be able to force the City Council to address the issue.

## ABM and WASHINGTON \*by Bill Peters

Washington Area Citizens Against the ABM, a broad-based coalition of 37 area groups, has been raising hell with the city, in the face of an ABM system being deployed in the Washington area.

The Nixon administration, already confronted with the fact that it won't pull wool over the eyes of certain Senators tried to present the "thin-missle system" as a compromise proposal. Convinced with the notion that all Americans want nothing more than to be "brought together again", it would be a real mindblow for Mr. Nixon, if he caught heavy resistance from the 'common folks' in the first two places he tried to place the systems. These two areas, North Dakota and Wahington D.C. have one thing in common- a suspected gullibility--no one expects to hear from North Dakota since we haven't heard from them before, and everybody knows that we'd want to save the Pentagon and the Capital Dome from nuclear attack. Besides, like North Dakota, D.C. residents are reputed to be apathetic and powerless in face of the guff we take from the Federal Goverment.

About five weeks ago, D.C. resident, Bob Lamb, went to North Dakota to organize opposition to the ABM. Lamb lobbied and pressured the governor to write Nixon a nasty letter. Next, we started hearing from heretofore unheard of campuses throughout the state, and cells of resistance sprang up in every N.D. town of over 5,000 people. Bob tells us that there isn't much hope in elevating resistance in North Dakota beyond the issue of local ABM installations, but great work anyway Bob!

The situation here in the District is a bit more exasperating. We know that the people are opposed to the missle sites, but it's our own local goverment who doesn't seem too concerned about it all. It would be naive to suggest that the City Council isn't aware that the \$700,000,000 allotted for area

ABMs couldn't be used to finance several transit systems, for a meaningful public housing program, or to finance a decently budgeted school system. Even Gilbert Hahn realizes that the questions raised by Prof Rockberg at the May 13th Council meeting ( Will the ABMs make D.C. an early target? , Are we prepared for the consequences of an accidental detonation of a rocket ? etc.) have to be answered. But then again, Mr. Hahn also realizes that the man who gave him his job, was also the same one who brought us the uncensored version of ABM. Also hanging over the Council's heads are the upcoming appointments (Presidential) to judgeships for three Council members.

-- We brought the issue to the City Council on May 6th—Gilbert Hahn in confronting the persistant and relevant questioning by WACAA spokesman, Art Waskow, showed that he owed more allegiance to the White House than to the people of the District. Waskow on the following night brought the issue in front of the School Board of all places. In arguing that the Board couldn't start to talk about improving conditions in the D.C. school system until costly projects like ABM are scrapped, Waskow pleaded with the Board, as the District's only elected body, to provide a forum for public hearings on the topic. The Board said no, but board member Julius Hobson, stated interest in possibly proving such a forum on his own.

Formal and informal WACAA meetings were held throughout the week, and we sprung back up again in public during a Council meeting on May 13th. Democratic Central Committee Chairman, Bruce Terris, physicist Prof. Rockberg of the U. of Md., John Carter of the Black United Front, and WACAA organizer John Gallman, again presented thier pleas for a public hearing on the issue. The Council hedged, procrastinated, and stayed uncommitted despite the direct questions fired by WACAA supporters at individual Council members.

If nothing else, WACAA members did public ly shame the City Council. The TV cameras were rolling, and the Council's silence was incriminating. It was apparent that the Council placed a higher priority on its petty procedures than on the desperate concern of the citizens of Washington, who they pretend to represent. The Council copped out again, but indications are that WACAA doesn't intend to follow suit.

There is some speculation among the radical elements of WACAA, that ABM isn't the overlying issue, that it is only a symptom of a militaristic and militaristic policy by our goverment. When viewed purely in this light, WACAA can be projected as a liberal cop-out, its efforts never getting down to the nitty-gritty until it broadens its base of concern to our other militaristic ventures. I personally maintain, that while there is a real danger of our patting ourselves on the back, over such a narrow issue, that the whole problem of ABM is one of the most important and viable issues to fall in our laps in a long time. Recent devolpments point out the following to me:

1.) Since the City Council has rejected us, and since the School Board can't help us, that we as municipal citizens are left powerless not only on the national but the local issues as well. This highlights the inability of an appointed government to represent us.

2.) Resistance from the two communities of North Dakota and Washington, could be enough to swing the already seriously split Senate into rejecting forever the whole ABM program.

3.) When the citizens of DC decide for themselves that it is in thier best interests to resist attempts to deply the missile system, they are in fact, due to the Council's inactivity practicing the valuable exercise of home rule.

4.) The question of any Abm deployment at all, has become a national (even an international) concern. The results of an effective area resistance to the ABM, is likely to have wider than local signifigance.

5.) The complexities of our military-industrial complex, are sometimes made more relevant, when brought into focus as a local issue having a lot to do with whether or not we have enough money to do the things that really are important in the city. Although other factors are involved, one thing is clear: the proposed system would channel .7 billion dollars on a perfectly useless project, when we have worthwhile local projects that are in serios need of funds.

This argument I have presented should not be taken as an apology for any inactivity by WACAA, but as a call for more of the same type actions, as we have had in the past week, if WACAA is to become

### A.F.S.C. VIGIL AT WHITE HOUSE

May 5-6---American Friends Service Committee, about 1400 strong from 20 states, staged the largest demonstration in front of the White House since Nixon took office. The message was clear - "Stop the killing in Vietnam". The message is hardly new to us, but it is hardly worn out. Each day it gathers more meaning.

Four representatives from AFSC talked to Nixon's aides; AFSC was told that the administration was doing all it could to end the war, and were asked to come back in two months to see if things weren't different. The Friends weren't satisfied with the explanations and said they would accept the invitation in two months.

The noon demonstration broke up at 3 pm, but many stayed to witness the 21 hour vigil that followed and the reading of the Vietnam death toll of 35,000 U.S. citizens. Beginning with James Alston of Alabama and concluding with Elliott Velez-Rodriguez of the Virgin Islands, it took the Friends 18 hours to read the list. Not read were the nameless and the countless -- the Vietcong and Vietnamese civilians killed during our presence in Vietnam.

The vigil ended on noon of May 6 with a silent prayer and a vow to keep coming back until the killing stops.

### NEW YORK FRIEND ARRESTED

(May 5) - John R. Flannagan was arrested on the charge of "demonstrating within 500 feet of a building occupied by an official of a foreign government". Flannagan, 34, strayed too close to Blair House, where Australian P.M. John Gorton was staying during the AFSC demonstration. Charged with bringing Gorton and Australia into public disrepute, Flannagan was caught red-handed carrying inflammatory signs reading "Walk in the light, stand fast in liberty" and "A Quaker appeal-Stop killing", "Support Friends healing in N. and S. Vietnam".

General Sessions Judge Milton

Kronheim found Flannagan innocent, but added that the arrest was proper because it was a court matter to interpret the signs - which says a lot for the court's respect for the cops' mentality.

### FRIENDS MEETING IN FRONT OF WHITE HOUSE

(6 May)--The topic under discussion was whether to stay or "pull out" in the face of possible arrests if visiting John Gorton came within 500 feet of the AFSC vigilers. I wish Mr. Nixon would have come out to see how Quakers really resolve differences.

Forty Friends and friends held a silent sit-down meeting on the sidewalk in front of the White House, concluding with a sensible dialogue on the pros and cons of the issue. The problem was resolved with the agreement that "everybody do his own thing and act responsibly". Warm handshakes followed.

The Australian Prime Minister side-stepped the vigilers and was greeted on the White House lawn by a fanfare of bugles, an honor guard, and a formal lunch at which he haggled with your Friend and mine - Mr. Nixon--Vietnam--"What can Australia do to keep up the war effort?"

### SCHOOL BOARD MEETING

(7 May)--Tonight the School Board revealed a study underway looking into the proposal of draft counseling services on the DC high schools, and suspended arbitrary suspensions until specific regulations were adopted.

### DRAFT COUNSELING

Two Eastern High students testified on behalf of the need for a draft counseling service in the public schools. Eastern student Theodore Miles stated that students were being drafted right out of high schools without first being advised of their rights.

SSS Regulation 1622.25 states that high school students are entitled to deferment in Class I-S until their 20th birthday. In replying, Julius Hobson said "some elements of our society think it is unpatriotic to advise people of their constitutionally guaranteed rights. Hobson then revealed a study being conducted by a George Rhodes who is still to turn his findings over to the board.

#### SUSPENSIONS AND CORPORAL PUNISHMENT

In a lively round of testifying and maneuvering, DC Action Committee Chairman Charles Cassell pushed past the bewildered Nelson Roots a unanimous decision to drop school suspensions without giving students a proper hearing.

Cassell said corporal punishment, made unlawful by the Skellywright decision, was causing a serious split between the teachers and the parents, which could spill over into the streets. Cassell demanded that 1) the Board issue a public statement that corporal punishment is against regulations, and 2) the Board announce a policy concerning suspensions, specifically that a due process of suspension procedures be made public and provisions be made by the school Board for suspended students.

In backing Cassell, Dr. Overby said that under the present system, students sometimes are kept out of school for seven months at a time. Mr. Willie Johnson, with a son in H.D. Cooke Elementary, said in a rousing speech, "I don't have to be a teacher to know my son isn't getting quality education...If the schools are to be the 'cradle of democracy', then we had better do some rocking!" Frequently heard in the testimonies were attacks leveled at Superintendent Mannin (who was not present) for his apathy towards the situation.

#### EXTENDED SESSION

Influenced by Cassell's plea for

leeway in the five minutes allotted to the citizen's testimonies, the Board stayed until 11:30 pm at the Lincoln Jr. High auditorium.

Herbert Smith of the Ad Hoc Dunbar Committee Council asked for an additional \$68,000 to be allotted for a focal point in community information and issued a hard-line statement warning capitalistic interests to stay out of the Dunbar project. The grant would be made to Dunbar High School.

About 60 enthusiastic Martha M. Washington students were disappointed to hear that the matter of an annex for their high school would have to await the unanticipated approval of a revised budget by the House Appropriations Committee. Like many of the 500 people present, the Washington students felt that their legitimate demands had to wait on the decisions by disinterested bureaucrats on the City Council and on Capitol Hill, far removed from the desperate situation on the home front.

**CITIZENS PRESS FREEWAY  
ISSUE**

(May 6)- In a public hearing, the City Council heard testimony from backers and friends of the plucky Emergency Committee for the Transportation Crisis. It soon became apparent that there was more to the testimony than the expected ETEC support for the Council's stand against the proposed North Central Freeway and Three Sisters Bridge.

The ETEC, spearheaded by their chairman R.H. Booker and Sammy Abbott of Save Tacoma Park Committee, in presenting damning evidence to the Council, revealed an unauthorized secret negotiation between Deputy Mayor Thomas Fletcher, Highway Dept. head Thomas Airlis, and Lt. Col. Sam Sterolin of the Army Corps of Engineers. Sam Abbott told of a heretofore unrevealed willingness of Mr. Fletcher to negotiate the issue, although the Council strongly denounced the proposed plan last December 12th. Mr. Booker leveled his attack directly at Fletcher, a San Diego native, and asked the Council to consider his demand that Fletcher be removed from his post.

ETEC, a diverse coalition of community groups, seem to be tenacious as ever in their demand, "not an inch of freeway in D.C.".

**A RAP, WITH SAMMY ABBOTT**

(may16) I rapped with Sammy Abbott yesterday and got zapped with the following facts which I think bears the attention of all concerned Washington residents:

\*A proposed Tydings-Broyhill bill now on the hill would give Congress the authority to appropriate (without City Council opinion), any D.C. real estate for parking purposes--the only areas exempt from this far-reaching bill will be already established parking lots.

\*Members of the executive branch of the D.C. Gov't. ... to split ETEC down black/white lines, by appealing to the interests of a white group, aimed at a "compromise settlement".

\*Compromising the freeway issue is like a woman being "halfway pregnant".

\*Washington already has more proportional freeway mileage than any other major city. In 1964 we led major cities with 42 miles of freeway per 10 square miles of land, and 79 miles per one million people.

\*D.C. highway construction costs (for major projects only), up until now are \$508, 263,000 and the proposed projects would have amounted to \$480,000,000 more by 1971.

\*Proposed freeways would have cut thru the black area of the city, leaving the white

areas virtually untouched. No meaningful "relocation" has been made for those families previously dislocated by freeways no

\*Overwhelming use of the freeways will be by white suburban commuters thru the nearly 80% black D.C.

\*Concrete rapid transit proposals are continually put off despite the fact that:

-Washington has more downtown auto rush hour traffic than New York City (91% use public transit)

-Washington has three times as many rush hour cars downtown than Chicago (83% use public transit)

-D.C. metropolitan area population will double by 1985 and treble by the year 2000.

\*The whole transportation issue is in reality a RACE issue bequeathed upon us by the D.C. subcommittee, led by suburban Senators

**WHAT WE DIDN'T COVER**

\* Occupation of Howard administration buildings by boycotting students, and the occupation of the Howard campus by unfriendly forces.

\*The DC school teacher walkout due to dehumanizing suspension procedures in the DC public schools.

\*The recent "busting" of people trying to sell the FREE PRESS after dark. Indications are that the paper itself is being purged, but we don't have the details as to how many people have been arrested or exactly why.

\*The backlash devoping as a result of SDS occupation of the SSI. GW is now prosecuting 15 of its students.

## EMMAUS HOUSE

Emmaus is a center for community action in the Catholic U., Brookland area of Northeast Washington. Best known in the past as the headquarters for Operation Outrage; the house activity is rapidly becoming centered around the work of the Washington chapter of Catholic Peace Fellowship as Outrage prepares to shift its offices to Seattle in June. The new co-ordinators of CPF, John Swinglish and Steffanie Burrowes, have moved quickly into action on the Washington scene, since the beginning of their work with the organization coincided with the DC9 action. John Swinglish is a member of the DC9 Defense Committee along with Kathy Wurtz, another member of the Emmaus Community. In addition the house has been busy putting out literature and helping organize the national boycott of Dow products.

A couple of weeks after the 9's action, three CPF members had their own Good Friday action on the steps of the National Shrine. As people were leaving the Good Friday services, the "Shrine-3" lit a nine-foot crucifix soaked in homemade napalm, and read statements about what they called "the lack of moral leadership in the Church". In an interesting sequel to the action; that the human Christ is persecuted daily by organizations supported by the Church and the University community.

On May 13th, CPF provided Catholic U. with its first taste of guerrilla theatre. The act on was occasioned by the visit of a US Army recruiter on the campus, and consisted of the ritual killing of a Viet Cong girl while the Church, represented by two priests in funeral garb, liberally dispensed holy water, incense, and encouraging words to the soldier who was beating the girl to death. The recruiter was confronted and invited to join in the killing of a "dirty commie", but he declined as did the 100 or so students who gathered to watch the action. Presumably, they prefer the killing be done by their henchmen in Vietnam, far removed

from their view.

Emmaus and CPF are committed to a continued escalation of anti-war activity until their message becomes clear to the political leadership in Washington and the insanity of war is finally realized. ince we are being delayed three days enroute to "press", we thought we'd catch up on the latest happening:

\* We got a note from the War Resisters League in New York, that their offices were broken into and unsacked. Among the missing is the very valuable national mailing list. Ask anybody who has had contact with the WRL, to drop them a line, they can start rebuilding their mailing list. The New address is 19 Lafayette New York, NY.

\* Remember the Lafayette Square '66"? The legal battle isn't over yet, but test cases from the 86 people busted at the demonstration in front of the White House on election day, so far indicates that the demonstrators had a right to protest on the square after all. The case will probably go up to the Supreme Court (Uncle Thurgood's cabin ??), where it is hoped that the city ordinance limiting the capacity of Lafayette Square to 500 people, as unconstitutional by virtue of the first amendment guaranteeing the right to peaceful assembly. It can be questioned whether or not the first amendment can be applied here--the 300 park and tactical police on hand were anything but "peaceful". PROJECT: When and they open the Square back up again, and you see 500 old ladies eating lunch and feeding pigeons on the benches, send an emergency alarm to the TAC Squad.

\* The Milwaukee 14 trial is still going on. After a weeks' nit-picking by the prosecution, it looks like the "14" will get to present their defense at the state trial this week. The state had been baying gamen with the trial date for a couple months, up until the trial, evidently, to try to foil mobilization of "14" supporters. Washington has a stake in the trials of our own John Higgenbothem, on the Church of Scientology here, part of the "14", who effectively destroyed the city's draft-les last September 24th with home-made napalm.

\* The Free Press has gotten up-tight with the Mother's of Invention concert at the Baltimore Civic Center, when they told the crowd, that if you were stupid enough to be caught with dope, you deserved to be busted. We won't make drugs a part of our editorial policy, except to add that perhaps Frank Zappa of the Mothers was right: if you're going to get busted, we feel that you might as well make it worth it.

The Free Press did have a legitimate gripe though, when they put down the policy of charging 4 bucks a "head" to see and hear "free" music. Part of the establishment tradition we are trying to overturn, is the standard that the good artist is the one who patronizes the socially elite and the wealthy classes. We stand in danger of adopting the same plastic standards if we pay insane amounts of money to look up at "hip" artists who aren't humble enough to put the new art where it belongs--out in the streets. Dig the free GROK concerts at the Kay Spiritual Life Center at American University evry Sunday afternoon. Alexandria Folklore Center coordinates many great events. Be-ins are scheduled at 'P-Street Beach' all summer, and the Summer in the Parks program is coming back to life. Dig the happenings at Dupont Circle, especially on Saturday nights when the Afro-drummers really jam.

\* We just got word that a Malcolm X Day will be held at Malcolm X Park (formerly Meridian Hill) on Monday the 18th from noon to eight. The public schools have declared that school kids are free to go to the rally if they so desire. WOW!!!

\* In the light of a most unfortunate letter printed in the Sunday Post, by the DC Democratic Central Committee Chairman, State of WAR editor, Bill Peters feels forced to take a second, more pessimistic look at the worth of the Washington Area Citizens Against the ABM. Though toned down, the letter apologizes for the "Unfortunate" behavior of a "few" at the City Council meeting last Tuesday:

## SECOND LOOK AT WACAA

A coalition is a hard thing to work and deal with. One must accept the fact that by virtue of definition, the purpose of a coalition is confined to the least common denominator or the interests (and only those interests) that all the groups have in common. The result is oftentimes, a narrow goal and watered down tactics, but then again one must be willing to accept the fact. This was certainly the case with the Washington Area Citizens Against the ABM.; the gut support for WACAA realizes that ABM is only a shadow of a militaristic/racist system lurking over our heads and imposing itself on people throughout the world not to mention groups of people here in the United States. We knew that some WACAA interest groups couldn't (or didn't) want to see the issue in this light; but it was further suspected that some people were in the game "only for the money"; only we didn't want to look at things that way. After all, you have to keep the faith if you are to pull even the short-range projects off. SO WHAT'S WITH BRUCE TERRIS ? ?

This editorial is not intended to be an attack on the commitment of the Democratic Central Committee chairman; but in the light that Bruce Terris has managed to build a powerful piece of political machinerey before DC has gained home-rule, we feel that Terris has an obligation to explain to us exactly how he stands; how far and how deeply he intends to go to uproot the militarism that has (uninvited) made itself at home in Washington DC. We feel Terris is obligated to answer these questions, plainly, without politically slurring the issue, if he expects any support at all from the vanguard advocates of home-rule

(The following was submitted to the editors of State of W.A.R. and is heartily endorsed by them.)

Washington area citizens claim that they are up in arms over the ABM. An ambiguous coalition of groups has formed under the name of WACAA and claims it is attempting to obtain public hearings on the ABM. The groups have been involved in two actions at the District Office Building and it seems somewhat elated over the possibility of actually forcing some type of ABM hearing---official or otherwise.

Claiming that each group, singly and individually, will be able to resist military encroachment is evasive at best. At worst, it is an excuse for no effective long-range action. Hopefully this is not the case in Washington. But, it must be added, no one seems to be especially excited about chemical/biological warfare or the possible introduction of a professional army. And this is a real threat that the ABM outcry is heard only because it hits home---literally.

What is needed more than anything else is a unified effort against militarism (this has not emerged) that is capable of acting upon a single issue (which WACAA is claiming to be doing). For, as ABM has shown, militarism cuts across and effects all groups in the country. And until the military stranglehold is relaxed, no group will accomplish whatever it defines as its ultimate purpose. In a word, WACAA must recognize that its work has only begun. Small victories easily turn into defeat if they are not a part of a larger effort.


